COVID-19 Vaccination Requirements - SECON -CNG-100.56

PURPOSE

Fully Vaccinated-

· 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or

· 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine

PROCEDURE / DIRECTIVE

- 1. All students are required to receive an approved COVID-19 vaccination as required by the New York State Department of Health, unless a reasonable accommodation is approved.
- MVHS will provide either on-site access to the vaccines or individuals may schedule vaccination through the New York State Vaccination website at https://covid19vaccine.health.ny.gov/
- Medical accommodations may be requested utilizing the attached request form (MVHS
 COVID-19 Medical Exemption Form). Medical exemption requests must be supported by a
 student's Physician or Certified Nurse Practitioner, and a final review and approval/denial will
 be made by MVHS administration. Students will be notified as soon as possible of approval/
 denial status.
- 4. Students will be required to provide either proof of vaccination (CDC vaccination card, Excelsior Pass, Electronic Health Record documentation), or have an approved reasonable accommodation, to be exempted from the requirements, prior to attending SECON.
- 5. Students are required to submit proof of vaccination or exemption to the Student Health Nurse.
- 6. Students not in compliance with the vaccination requirement, or without an approved exemption, are subject to dismissal from the program.
- 7. Students with an approved exemption from vaccination may be subject to COVID-19 testing, or other alternative safety measures at the discretion of SECON or as required by law.
